The Petitioner/Wife, ELIN MARIA PERNILLA WOODS, by and through her undersigned counsel and pursuant to Chapter 61, *Florida Statutes* (2009), hereby files Petitioner/Wife's Petition for Dissolution of Marriage ("Petition"), and for same alleges:

1. Action for Dissolution. This is an action for dissolution of marriage between the parties, ELIN MARIA PERNILLA WOODS (hereinafter "Wife") and ELDRICK TONT WOODS (hereinafter "Husband").
2. Residence. The parties have been residents of the State of Florida for more than six (6) months before filing this Petition.
3. Venue. Venue is proper in this matter as the parties have consented to venue before this Court.
4. Marriage. The parties were married to one another on October 5, 2004.
5. Irretrievably Broken. The marriage between the parties is irretrievably broken.

6. Minor Children. There are two (2) minor children of the marriage: Sam Alexis Woods, born [redacted] and Charlie Axel Woods, born [redacted]. No children were adopted, and none are contemplated or expected.

7. UCCJEA Compliance. A completed Uniform Child Custody Jurisdiction and Enforcement Act (UCCJEA) Affidavit is filed with this Petition.

8. Marital Settlement Agreement. The parties have entered into a Marital Settlement Agreement (“MSA”) dated July 3, 2010 and signed by the parties on July 3 and 4, 2010. Said MSA includes a Parenting Plan signed by the parties on July 3 and 4, 2010. The Wife requests that this MSA be adopted and confirmed by the Court and that the parties be ordered to fully comply with its terms.


9. Parenting Plan. The Parenting Plan is in the best interests of the minor children.

WHEREFORE, the Petitioner/Wife respectfully requests of this Court to enter a final judgment providing for:


- A. Jurisdiction of this action and entry of a Final Judgment of Dissolution of Marriage;
